The last, the writer analyzed the constructions of the passive sentences found in the Education Headline News of Jakarta Post. The formation of passive sentence consists of the subject, be, past participle, and by phrase. It also includes the form of tenses not in generally constructed.

F. Operational Definition

There are some terms of the research in order that make the readers understand, those are :

- 1. A passive sentence is one of grammar forms to make a sentence that the subject of the active sentence becomes the agent.
- 2. The tenses of passive sentences means kinds of the tenses that usually use, for example passive present tense, passive past tense, etc.
- 3. Constructing the passive voice, therefore, involves the inversion of the noun phrase (NP) subject and NP object positions (Amadi, 2018), then consists of positive passive voice that used to show interest in the person or object that experiences an action rather than the person or object that acts. A negative passive voice is a sentence that has refusal meaning or negative meaning. Interrogative passive voice is a question sentence with a question mark.
