



**ABSTRAKSI**

**Analisis Pengaruh Efektivitas, Profitabilitas, Likuiditas, dan Leverage terhadap Kebijakan Dividen pada Perusahaan Manufaktur yang Terdaftar di Bursa Efek Indonesia Periode 2016-2021**

Penelitian ini bertujuan untuk memperoleh bukti empiris tentang pengaruh efektivitas, profitabilitas, likuiditas, dan leverage terhadap kebijakan dividen. Variabel independen yang digunakan yaitu efektivitas, profitabilitas, likuiditas, dan leverage. Variabel dependen yang digunakan yaitu kebijakan dividen. Populasi dalam penelitian ini adalah perusahaan manufaktur sub sektor food and beverage yang terdaftar di Bursa Efek Indonesia (BEI) periode 2016-2021. Sampel yang dikumpulkan dengan menggunakan metode purposive sampling. Sebanyak 8 perusahaan digunakan sebagai sampel. Metode analisis dalam penelitian ini menggunakan regresi linear berganda. Hasil penelitian ini menunjukkan jika efektivitas dan leverage berpengaruh negatif dan signifikan terhadap kebijakan dividen. Profitabilitas berpengaruh positif dan signifikan terhadap kebijakan dividen. Sedangkan likuiditas berpengaruh positif dan tidak signifikan terhadap kebijakan dividen.

**ABSTRACT**

**Analysis the Effect of Effectiveness, Profitability, Liquidity, and Leverage on Dividen Policy in Manufacturing Companies Listed on the Indonesia Stock Exchange in 2016-2021.**

This study aims to obtain empirical evidence about the effect of effectiveness, profitability, liquidity, and leverage on dividend policy. The independent variables used are effectiveness, profitability, liquidity, and leverage. The dependent variable used is dividend policy. The population in this study is the food and beverage sub-sector manufacturing companies listed on the Indonesia Stock Exchange (IDX) for the 2016-2021 period. Samples were collected using purposive sampling method. A total of 8 companies were used as samples. The method of analysis in this study uses multiple linear regression. The results of this study indicate that effectiveness and leverage have a negative and significant effect on dividend policy. Profitability has a positive and significant effect on dividend policy. Meanwhile, liquidity has a positive and insignificant effect on dividend policy.
